Objectives and investment policy

Objective: To generate income and preserve the value of the shareholder's investment over the short term (income and capital preservation).

Investment policy: The Fund invests 80% or more of its total net assets in cash deposits and other similar investment types.

Derivatives: The Fund may use derivatives for efficient portfolio management, which includes reducing exposure to various investment risks (hedging).

Benchmark: The Fund is actively managed within its investment objective and policy, and is not limited by any benchmark.

This Fund is a standard:

- Variable Net Asset Value Fund.
- Money Market Fund

This Money Market Fund is:

- Not a guaranteed investment.

- Different from an investment in deposits, with particular reference to the risk that the principal invested in an MMF is capable of fluctuation.


