#### **Objectives and investment policy**

Objective: To generate income and increase the value of the shareholder's investment over the long term (capital growth and income).

Investment policy: The Fund invests 80% or more of its total net assets in UK equities that feature in the FTSE 250 Index. Other UK listed equities may be held where the Investment Manager deems this appropriate.

The Fund's equity investments can include all types of equities and equity related securities.

Derivatives: The Fund may use derivatives for efficient portfolio management, which includes reducing exposure to various investment risks (hedging).

Benchmark: The Fund is actively managed, and the Investment Manager has freedom to select stocks within the constraints of the investment objective and policy.

If you invest in income shares, income from investments in the Fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

You can normally submit instructions to buy and sell shares in the Fund, between 9am and 5pm, on any day which is a working day in London. However, please see aberdeenstandard.com for details of any non-dealing days.


