Objectives and investment policy

The Fund aims to provide capital growth over 10 year periods investing at least 80% in a concentrated portfolio of global equities.

The Fund may also hold up to 20% in cash.

The Fund may also make other investments, including:

- other transferable securities
- other investment funds
- warrants
- deposits and money market instruments

There are no geographical or sector restrictions on the Fund.

The concentrated portfolio of global equities will be made up of equities that may provide, in the Investment Manager's opinion, strategic value. These will be opportunities which have business franchises that are currently trading at a significant discount to the Investment Manager's appraisal of their fair value.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

Net Income Shares: Any income the Fund generates will be paid out to you.

Net Accumulation Shares: Any income the Fund generates will be reinvested.

You can buy and sell shares on any working day in London.

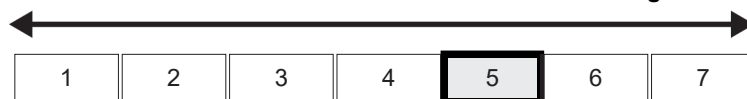

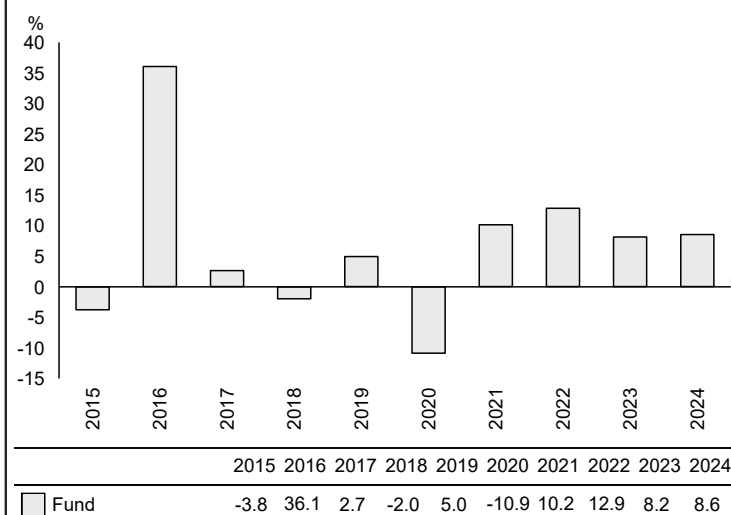
