Baillie Gifford Worldwide Global Stewardship Fund ("the Fund") is a sub-fund of Baillie Gifford Worldwide Funds PLC (the Company). The Fund is managed by Baillie Gifford Investment Management (Europe) Limited.

### Objectives and investment policy

#### Objective

The Fund aims to provide returns, through combined capital growth and income payment, over the long term, by investing primarily in shares of companies globally which meet the relevant environmental, social and governance criteria, excluding companies from certain industries and companies which are inconsistent with the principles of United Nations Global Compact for Business.

#### Policy

- The Fund will invest at least 90% in shares of companies globally which demonstrate long term growth prospects and good stewardship, indicators of which include long term strategic direction and culture of a company, the capital allocation skill of management teams, and the level of alignment with customers, employees and outside shareholders.
- Investments will be selected following application of sector-based screen and norms-based evaluation.
- Investments in companies that derive annual revenues above a particular level from tobacco, alcohol, gambling, armaments, adult entertainment or fossil fuel extraction and production are not permitted. The Fund will not invest in companies that are assessed as inconsistent with global norms covering areas including human rights, labour rights, environmental safeguards and combating bribery and corruption.
- The Fund is actively managed and no index is used for the purposes of determining or constraining the composition of the Fund's portfolio. The Fund's performance (after deduction of costs) is measured against the MSCI ACWI Index. The Fund seeks to materially outperform the index.

#### Other Information

- You can sell some or all of your shares on any day on which banks in Ireland are open for business by contacting the Transfer Agent by phone or post.
- Income will be re-invested. No further shares will be purchased but the reinvestment will be reflected in the price of your existing accumulation shares.

- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within five years.

### Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.

- Please note that even the lowest risk class can lose you money and that extreme adverse market circumstances can mean you suffer severe losses in all cases.
- The Fund is classified in the category above because it invests in company shares which generally provide higher rewards and higher risks than other investments such as bonds or cash. Where no share price history is available for any part of the last five years (and thus no returns), the returns of the Fund's comparative index is used in its place to calculate the Risk and Reward Indicator.
- The indicator does not take into account the following relevant material risks:
  - Investment markets can go down as well as up and market conditions can change rapidly. The value of an investment in the Fund, and any income from it, can fall as well as rise and you may not get back the amount invested.
  - The Fund has exposure to foreign currencies and changes in the rates of exchange will cause the value of any investment, and income from it, to fall as well as rise and you may not get back the amount invested.
  - The Fund invests in emerging markets where difficulties in trading and custody of assets could arise, impacting your investment.
  - The Fund employs stewardship and ethical screens which means it cannot invest in certain sectors and companies. The universe of available investments will be more limited than other funds that do not apply such criteria/ exclusions, therefore the Fund may have different returns than a fund which has no such restrictions. Data used to apply the criteria may be provided by third party sources and is based on backward-looking analysis and the subjective nature of non-financial criteria means a wide variety of outcomes are possible. There is a risk that data provided may not adequately address the underlying detail around material non-financial considerations.

## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

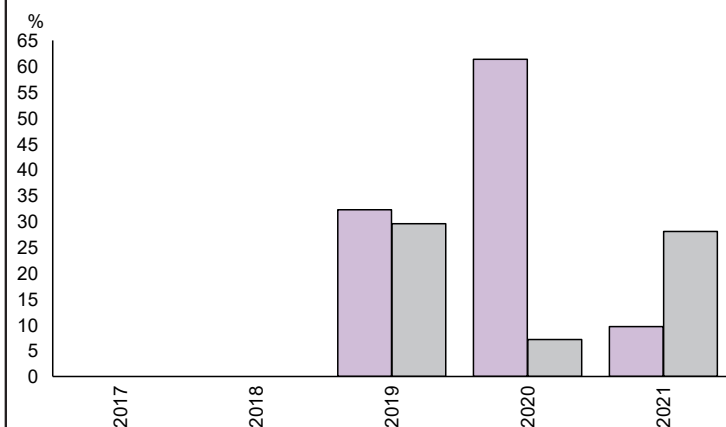
