The Authorised Fund Manager of the Fund is Tutman Fund Solutions Limited, trading as St Vincent St Fund Administration, part of the Thesis group.

Objectives and investment policy

The Fund aims to achieve long-term capital growth over a period of at least 5 years.

The Fund will invest at least 80% in shares of European (excluding the UK) companies (those listed, quoted or traded in European markets or those which have a significant part of their activities in Europe but which are quoted on a regulated market outside Europe).

The Fund may also invest in:

- other shares outside Europe
- other transferable securities
- other investment funds
- cash, deposits and money market instruments
- warrants.

To the extent that the Fund is not fully invested as set out above, the Investment Manager has the flexibility to invest in new issues meaning, typically, Initial Public Offerings (or IPOs), which generally mark the first sale of shares by a privately-owned company in order to gain a stock market listing. However, it may also include "share offers" (meaning sales of stock by companies that are already listed on one of the Fund's eligible markets), which will necessarily have a higher risk than investments in established companies.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Any income the Fund generates will be paid out to you.

You can buy and sell units on any Business Day in London.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



- The Fund is in a higher category because the price of its investments have risen or fallen frequently and more dramatically than some other types of investment. - The Fund is entitled to use derivative instruments for EPM. Derivatives may not achieve their intended purpose. The organisation from which the Fund buys a derivative may fail to carry out its obligations, which could also cause losses to the Fund.
- The Fund invests primarily in one geographic region and will have greater exposure to market, political, legal, economic and social risks of that region than if it diversifies risk across a number of geographic regions.
- The Fund may hold a limited number of investments. If one of these investments falls in value this can have a greater impact on the Fund's value than if it held a larger number of investments.
- The Fund may invest in securities not denominated in sterling, the value of your investments may be affected by changes in currency exchange rates.

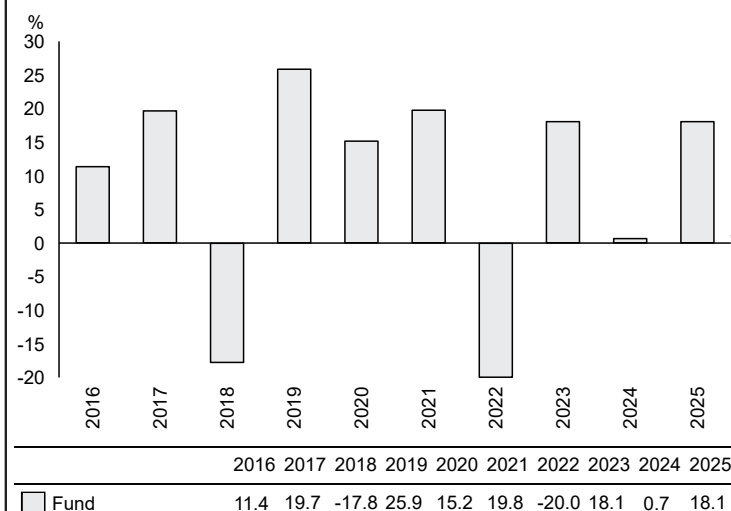
