The Fund is a sub-fund of SVS Saltus Onshore Portfolios.
The Authorised Corporate Director of the Fund is Evelyn Partners Fund Solutions Limited, part of the Evelyn Partners group.

Objectives and investment policy

The investment objective of the Fund is to generate a combination of income and capital growth over the long term (rolling 7 year periods), with a volatility of returns of no more than 5/6th of the volatility level of MSCI AC World Index (over rolling 3 year periods).

The Fund will invest at least 80% in other investment funds which themselves invest in:

- equities and fixed income securities (including but not limited to shares and bonds issued by governments and other organisations)
- cash, deposits and money market instruments
- currencies
- gold
- property
- warrants
- derivatives

To the extent that the Fund is not fully invested in other collective investment schemes, it may invest directly in the asset classes listed above (with the exception of: (i) derivatives which may be used by the Fund only for the purposes of efficient portfolio management; (ii) gold; and (iii) property).

In order to achieve the investment objective, the Fund will be managed to a high risk and volatility level meaning that the allocation to particular asset classes may vary over time at the Investment Manager's discretion as is consistent with a high risk and volatility level. However, the Investment Manager may manage the Fund outside the expected high volatility parameters due to such parameters being based on historical data.

Investors should note that their capital is at risk and that return and volatility goals are intended as target with no guarantee that they will be achieved over any time.

The investment policy will create a widely diversified portfolio of investments across multiple asset classes, geographies, styles and strategies.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital. The Fund may use derivatives and forward transactions for investment purposes on giving 60 days' notice to Shareholders. The use of derivatives for investment purposes may alter the risk profile of the Fund.

Any income the Fund generates will be paid out to you. You can buy and sell shares on any working day in London.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.

- The Fund is in a higher category because the price of its investments have risen or fallen frequently and more dramatically than some other types of investment. - The Fund is entitled to use derivative instruments for EPM. Derivatives may not achieve their intended purpose. Their prices may move up or down significantly over relatively short periods of time which may result in losses greater than the amount paid. This could adversely impact the value of the Fund. The organisation from which the Fund buys a derivative may fail to carry out its obligations, which could also cause losses to the Fund.
- The price of gold or other resources may be subject to sudden, unexpected and substantial fluctuations. This may lead to significant declines in the values of any companies developing these resources in which the Fund invests and significantly impact investment performance. The Fund may invest in securities not denominated in sterling, the value of your investments may be affected by changes in currency exchange rates.

Charges
