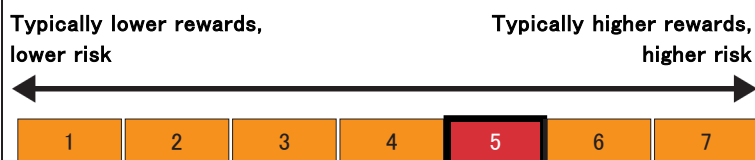
Objectives and investment policy

To track the performance of low volatility emerging market shares as represented by the FTSE RAFI Emerging Low Volatility Custom Screened Index (the "Benchmark Index") by investing in emerging market shares. The Fund aims to perform in line with the Benchmark Index before deduction of fees. The Fund aims to invest in shares of all of the companies within the Benchmark Index. This is often referred to as a 'full replication' approach. Where Scottish Widows Unit Trust Managers (SWUTM) believes it can provide an advantage to the Fund in managing costs, to achieve a more efficient way of tracking the Benchmark Index, or where there are exceptional market circumstances, the Fund may include or exclude specific shares and/or other security types which are representative of a share in the Benchmark Index (such as depositary receipts). The Fund may also invest, up to 10%, in collective investment schemes to gain exposure to the Benchmark Index. Investment weightings will be based on fundamental factors and low volatility characteristics rather than market capitalisation. The Benchmark Index targets stocks which have historically exhibited lower levels of volatility relative to the broader market (i.e. indices which are not low volatility). The term "low volatility" should be viewed relative to an equivalent equity index constructed on a market capitalisation basis, rather than an absolute basis. There's no guarantee the Fund will be less volatile than an equivalent market capitalisation index or fundamental index, particularly over shorter time periods. Market capitalisation is the total market value of a publicly traded company's shares. For a market-capitalisation weighted index the weight of each company in the index is driven by the size of that company. This means that the larger the company, the greater the weighting it has in the index. A fundamental index is weighted differently. Investment decisions for a fundamental index fund depend on a company's fundamental financial measures, not just its market value. Examples of fundamental factors can include sales, cash flow, book value and dividends. Derivatives and stock lending may be used for the purpose of managing the Fund in a way that is designed to reduce risk or cost and/or generate extra income or growth (often referred to as efficient portfolio management). The Benchmark Index has been selected as an appropriate benchmark as it measures the performance of a sub-set of equity securities within the FTSE RAFI Emerging Low Volatility Index (the "Parent Index"). The Parent Index provides a representation of the returns of low volatility securities in emerging markets weighted using fundamental factors. The Benchmark Index excludes companies from the Parent Index based on the ACD's exclusions screening criteria. Information on the Benchmark Index: The Benchmark Index is a custom index which excludes the following companies from the Parent Index:

- Manufacturers of controversial weapons prohibited by international conventions such as anti-personnel landmines, cluster munitions, chemical and biological weapons;
- Companies which do not meet one or more of the ten United Nations Global Compact principles. Those cover, but are not limited to, human rights, anti-corruption and the environment;
- Companies where 5% or more of their revenue is derived from Thermal Coal extraction and/or Tar Sand operations;
- Companies where 10% or more of their revenue is obtained via activities within Tobacco production, sales or related services. Note: the Fund will underperform the Benchmark Index after the deduction of fees. Investors should aim to hold their investment in the Fund for the medium to long term (at least five to ten years). Any income received by the Fund is retained in the Fund and has the effect of increasing the share price.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



- The Fund is ranked at 5 because it has experienced medium to high levels of volatility over the past 5 years.
- The value of your investment and any income from it is not guaranteed and can go up and down depending on investment performance.
- Specific investment risks for the Fund are:
 - Company shares ('equities') generally offer higher long term growth potential than some other asset classes. Values can fluctuate considerably. There's a greater risk you might not get back all of your money.
 - Emerging markets may suffer large price fluctuations. They are generally less well regulated than UK markets with less investor protection. Assets may be traded less often and in low volumes.
 - Where a Fund seeks to perform in line with an index there is a risk its performance might be below that of the index.
 - The benchmark index may be determined, composed or calculated inaccurately by the Index provider. This may affect the performance of the fund, may lead to gains or losses and may not be identified and corrected for a period of time.
 - The Fund is designed to measure the performance of equities which have historically exhibited low levels of volatility. There is no assurance that future performance will be less volatile than funds tracking other stockmarket indices or funds which are not tracking an index, particularly over shorter time periods.
 - While the Fund targets low volatility equities, it remains subject to stockmarket fluctuations.
 - Exchange rate changes might cause the value of overseas investments and any income from them to go up and down.
 - The use of derivatives for Efficient Portfolio Management might not achieve the described outcomes and may result in greater fluctuations of the value of the Fund, however it is not intended that this will cause the risk profile of the Fund to change.
 - Due to exclusions applied, the Benchmark Index has a narrower universe of securities than the Parent Index, and this may result in a difference between the performance of the Fund relative to the funds which track the same Parent Index.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
