Baillie Gifford Worldwide Emerging Markets Leading Companies Fund ("the Fund") is a sub-fund of Baillie Gifford Worldwide Funds PLC (the Company). The Fund is managed by Baillie Gifford Investment Management (Europe) Limited.

Objectives and investment policy

Objective

- The Fund aims to maximise the total return, mainly through capital growth.

Policy

- To invest in any economic sector in emerging markets worldwide, either directly or indirectly.
- Investment will be mainly in shares of companies.
- We will decide what constitutes an emerging market.
- Investments will be selected following application of business activity-based exclusions and norms-based evaluation.
- Investments in companies that derive annual revenues above a particular level from tobacco, armaments or thermal coal extraction and production are not permitted. The Fund will comply with the Investment Managers policy on assessing breaches of the United Nations Global Compact Principles for Business.
- The Fund is actively managed and no index is used for the purposes of determining or constraining the composition of the Fund's portfolio. The Fund's performance (after deduction of costs) is measured against the MSCI Emerging Markets Index. The Fund seeks to materially outperform the index.

Other Information

- You can sell some or all of your shares on any day on which banks in Ireland are open for business by contacting the Transfer Agent by phone or post.
- Any income due to you will be paid into your bank or building society account, paid on the dates specified in the Prospectus.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.
